Picnic Shelter Rules and Liability Waiver

Whitley Park is a neighborhood park. Those who rent a picnic shelter at Whitley Park must always be respectful of residents who live adjacent to the park!!

The following rules apply to all groups or individuals who use a Town Park Shelter. Anyone who does not adhere to all of these rules may be asked to leave the park WITHOUT a refund of fees paid.

- 1) Never park on any street or in the interior of any park. You may only park in marked spaces. If reserving Whitley Park, overflow parking must be done in the grass lot (Alford Lot) on the opposite end of the park.
- 2) Shelter rentals are restricted to the following numbers:
Whitley Park – 50 people (MUST STILL ALLOW FOR SOCIAL DISTANCING)
All Others – 75 people (MUST STILL ALLOW FOR SOCIAL DISTANCING)
- 3) One household grill may be brought to the picnic shelters (gas or charcoal). NO PIG COOKERS ALLOWED!!
- 4) No stereos, boom boxes, amplification of sound, microphones, or speakers are allowed.
- 5) No blowup units, bouncy houses, jumping units, or carnival type rides are allowed at ANY of the parks or park shelters.
- 6) All park shelters close at sundown. Please plan accordingly so that you are out of the parks sundown.
- 7) You must include setup and cleanup in your reservation time. Example: You want a 2 hour birthday party and you need an hour to set up and an hour to clean up. In this instance you would need to rent the shelter for 4 hours.
- 8) No alcoholic beverages are allowed in any park!!
- 9) Park shelter renters are expected to clean up after themselves. Please make sure all trash is placed into trash cans and make sure the lids are secured in place as well.
