#### **Executive Summary:**

The Board of Commissioners will consider how and when to reschedule a canceled meeting and change the time of a work session meeting.

#### Background:

On August 3, 2020 hurricane Isaias was tracked to come through our area and the Board of Commissioners meeting was canceled out of safety for the community and staff. The Board can reschedule the meeting one of two ways:

- Call for a Special Called Meeting which requires 48 hours notice and the agenda cannot be amended or deviated from for that meeting.
- 2. Amend the Regular Meeting Schedule to include the date and time that the Board would like to reschedule the meeting, but they must wait 7 days after the schedule is amended to meet.

Changing the time for the work session scheduled for August 19, 2020 is also requested. There is a desire to change the time of the work session to an earlier time due to the content of the meeting being lengthy.
