### Background

The Town budgets on an annua fiscal yearl basis. The Board of Commissioners adopt a budget prior to the end of June for the fiscal year beginning in July and ending in June.

Budget development is an ongoing process for staff and the Parks and Recreation Department is currently working to develop initial budget requests for the next budget year. As we work to prepare our budget request, the department wishes to hear from the Parks & Recreation Advisory Board. Staff will provide a brief overview and engage with the Advisory Board on a series of topics to provide considerations for staff as the budget recommendation is prepared.

Advisory Board Members are encouraged to review Play Zebulon, the Parks and Recreation Comprehensive Master Plan (sections 4 and 5).
