5. Staff Updates

- Athletics (J Hardin) Basketball season ended with post season play in SWAC tournament. Baseball, Softball, T-Ball, Soccer underway. Uniforms Ordered. Continuing to work on details for Opening Day (April 27th). Looking for part-time staff to help with Soccer.
- Parks (J Beck) Mulch at Whitley Park. Boy Scouts volunteering at Community Park. Nature Play equipment to be installed at Little River Park after the removal of the existing play equipment which is outdated and does not meet safety standards.
 - J Harris noted that a fence went up along the backside of Whitley Park and J Beck stated it was installed by a homeowner.
- Community Center (S Long) Basketball ended. Pickleball gearing back up. Child fitness and nutrition programs started. Rentals booked every weekend.
- Programs (S Long) Summer camps available. Events (Celebrate the arts @ ZTH 4/26, May Day @ ZTH 5/4)
- Farm Fresh Market (S Long) Maurine Brown has resigned and has begun working in Rocky Mount. Not immediately filling the position. We will take time to evaluate efficiency and consider needs of the organization and how the market fits into that. Opening Day April 27th. New brewery is looking at past success of Koi Pond Brewing at the market and is also interested in establishing building in Zebulon.
- Administration (S Long)— Walkability CIP Committee is going to reconsider recommendation for the next budget year. No new budget update at this time. Staff Wellness Program will be hosting a lunch & learn session on March 20th and is encouraging staff to participate in walking clubs and other fitness programs.
