Zebulon Board of Commissioners Minutes October 5, 2020

Commissioner Clark made a motion, second by Commissioner Baxter to approve the agenda. There was no discussion and the motion passed unanimously.

Mayor Matheny recognized student Ashlyn Bowling and teacher Crystal Detty, both from Wakelon Elementary School.

PUBLIC HEARING

A. AN 2020-03 – 1007 North Bell Street Mayor Matheny opened the public hearing.

Michael Clark presented the annexation request AN 2020-03. The applicant was Leslie Privette and the address was 1007 N. Bell Street. The existing zoning was R4, residential neighborhood and the parcel size was one acre. The aerial map and zoning map were shown. Michael Clark explained that it would be the property owner's responsibility to install sewer service if annexed. Staff recommended support of the proposed annexation.

Leslie Privette, of 2509 Holiday Avenue, stated the property had water access through the City of Raleigh, but did not have sewer access. The property had an existing septic system. Ms. Privette stated she wanted to split the lot in half and add an additional home to the right side of the property. A sewer connection was necessary to add a home since two septic systems were not allowable on the property.

Commissioner Loucks inquired about the building equipment damage clause. Eric Vernon explained the City of Raleigh had reserved the right to pass along any additional costs to the Town.

It was explained the Town could include announcement inserts with invoices.

There was discussion about the late fees and collection fees that could be assessed.

It was reiterated that the Town of Zebulon would have no responsibility to install sewer service. The property owner would be responsible for the installation of the sewer service if annexed.
