CONSTRUCTION DRAWING APPLICATION

GENERAL INFORMATION:

A construction drawing in accordance with Section 2.2.7 of the Unified Development Ordinance is to establish a consistent and predictable process for the review of proposed development, through a graphical representation of the proposal. Construction Drawings review is an analysis to ensure that allowable development is configured in accordance with the standards in this Ordinance, not a consideration of whether or not a proposed development is allowed.

INSTRUCTIONS:

PRE-APPLICATION MEETING: A pre-application meeting with staff in accordance with Section 2.3.2 of the UDO to verify the application requirements, processes, and procedures regarding a proposed request. To schedule a meeting, applicants must e-mail a pdf map, drawing, model, site, or sketch plan to planning@townofzebulon.org no later than five (5) working days prior to the desired meeting day.

ANNEXATION REQUIREMENTS: If a property or portion thereof subject to this site plan request is outside the corporate limits and ETJ, an annexation petition is required to be submitted on the same day as this application in accordance with section 2.2.2 of the UDO.

APPLICATION PROCEDURE – The applicant requesting Construction Drawing Approval must submit an application through the Town of Zebulon Geocivix permit portal. As noted below some materials must be brought in person to the Zebulon Planning Department to complete the application process.
